Call to Order:

Chairman Brusso called the meeting to order at 12:08 p.m. A quorum of the Agency's members were present.

Approval of IDA Meeting Minutes of November 3, 2022

The minutes of the Agency's meeting of November 3, 2022 had been sent to Board members prior to the meeting. A motion was made by Mr. Tom Murray to approve the minutes. Seconded by Mr. Kime. Motion carried.

Approval of November 2022 Financial Statements:

The November 2022 financial statements had been mailed to board members prior to the meeting. Mr. Brusso summarized the financial statements for the board. A motion was made by Mr. Kime to approve the financial statements. Seconded by Mr. Guthrie. Motion carried.

Review | Approval of IDA Resolution 2022-17 / Request for Consent Under the Leaseback - BonaDent:

A copy of the proposed resolution was provided to board members prior to the meeting. Bruce Henry Properties (aka BonaDent) is seeking board approval to continue their existing IDA PILOT pending a recapitalization of the company. There will be no loss of employment as a result of the recapitalization and the company's headquarters will remain in Seneca Falls. Mrs. Wirth and Mr. Griffin gave an overview of the recapitalization to the board. The resolution was presented as follows:

RESOLUTION OF THE SENECA COUNTY INDUSTRIAL DEVELOPMENT AGENCY (THE "AGENCY") CONSENTING TO ASSIGNMENT OF INTERESTS UNDER AMENDED AND RESTATED LEASEBACK AGREEMENT

A motion was made by Mr. Tom Murray approving Resolution No 2022-17 / Request for Consent Under the Leaseback – BonaDent. Seconded by Mr. Kime. Members Brusso, Guthrie, Kime T. Murray, Shipley voted "yea". Mr. Trout, Mr. Lott and Mr. Bruce Murray were absent. Motion carried.

Review | Approval of IDA Resolution No 2022-18 / Kanagy Solar Farm Project / Inducement:

A copy of the proposed resolution and application were provided to board members prior to the meeting. Kanagy Solar Farm LLC is seeking a PILOT and sales and mortgage recording tax exemptions to support the \$5.795 million construction of a 3.6 MW community solar farm in Romulus. Mr. Gourley gave an overview of the project to the board. Approval of the inducement resolution will allow staff to conduct a cost-benefit analysis and hold a public hearing for the project. The resolution was presented as follows:

RESOLUTION OF THE SENECA COUNTY INDUSTRIAL DEVELOPMENT AGENCY (THE "AGENCY") (i) ACCEPTING THE APPLICATION OF KANAGY SOLAR FARM LLC (THE "COMPANY") DATED NOVEMBER 11, 2022 WITH RESPECT TO A CERTAIN PROJECT, (ii) AUTHORIZING A PUBLIC HEARING WITH RESPECT TO THE PROJECT, (iii) DESCRIBING THE FORMS OF FINANCIAL ASSISTANCE BEING CONTEMPLATED WITH RESPECT TO THE PROJECT, AND (iv) AUTHORIZING THE NEGOTIATION OF A LEASE AGREEMENT, LEASEBACK AGREEMENT, PILOT AGREEMENT AND RELATED DOCUMENTS

A motion was made by Mr. Guthrie approving IDA Resolution No 2022-18 / Kanagy Solar Farm / Inducement. Seconded by Mr. Shipley. Members Brusso, Guthrie, Kime T. Murray, Shipley voted "yea". Mr. Trout, Mr. Lott and Mr. Bruce Murray were absent. Motion carried.

Approval of Items to be Disposed per Supplies and Equipment Policy:

In accordance with the IDA's Supplies and Equipment Policy, a list of obsolete office items is to be presented to the board for disposal. One disposable item to note is the office copier / printer.

Board Meeting Schedule 2023:

A proposed meeting schedule for the monthly 2023 IDA Board Meetings had been mailed to Board Members prior to the meeting. The updated schedule can be found on the IDA Website.

RLF Loan Status Report:

A copy of the loan status report was provided to board members prior to the meeting. Currently there are three loans, and all are current. No action is required.

Mr. Lott arrived at the meeting.

Update on Willard:

IDA staff has developed a Gantt chart to help with the project management of the redevelopment of the Willard site. A copy of the chart was provided to board members. Additionally, staff has sent out the Request for Proposals "RFP" for the Willard Highest & Best Use Study. The deadline for proposals is the end of January 2023. A group of 16 community leaders has been assembled to participate in the Willard Task Force. The group had its first meeting on November 21st and will continue to meet monthly to share updates on the redevelopment efforts; find ways to engage the community; and assess costs, funding sources, and other specifics related to the redevelopment.

The NYS Prison Redevelopment Commission is expected to release its report with recommendations pertaining to the state's closed correctional facilities by the end of the year. Members of the Commission have indicated that the group will be recommending the state transfer the prisons to their respective localities for redevelopment. Additionally, the Commission is expected to recommend two new funding programs be included in the 2023 NYS budget to support planning and capital improvements for the closed facilities.

<u>Standing Item – Update / Seneca County Chamber of Commerce:</u>

Mr. Shipley gave the following update to the board. One Seneca is continuing to have their weekly meetings every Thursday at 10am. Mr. Shipley noted a topic that came up in discussion at today's One Seneca meeting was the Micron development in Syracuse and the potential development this project could bring to Seneca County. It

would be good for the board to come up with ideas on how to bring in some of those ancillary business that might come from that project.

Mr. Shipley also noted that one of things that Chamber does and is currently working on now is the offering of health insurance policies to local businesses for their employees. The Chamber being able to offer this service is a real benefit to the community.

Annual Report from IDA Executive Director:

A copy of the Report was provided to Board Members prior to the meeting. Mrs. Davis gave the following update to the board:

This year has been marked by a lot of change within the IDA—most notably, the retirement of our long-time Deputy Director Pat Jones and the hiring of our Grants & Development Specialist David Hewitt. We have also brought on two new board members (Ralph Lott and Ben Guthrie), expanded our Business Retention & Expansion (BR&E) program even further, and become a key participant in the efforts to redevelop the Willard Drug Treatment Campus.

What We Accomplished:

The IDA's focus in 2022 has been largely on continued process and programmatic improvements as well as relationship building with key community partners. Some of the key accomplishments following this theme include the creation and implementation of a new chart of accounts and new project fee schedule, staff participation in 8 professional development opportunities, and significant expansion of the BR&E program to include 63 business visits.

Agency staff have prioritized relationship building with regional and local partners via interactions with the One Seneca group and Willard Task Force and via attendance at key events, including Regional Economic Development Council Meetings, Greater Rochester Enterprise board meetings, IDA Academies, and the GROW NY summit. Local efforts to redevelop the Willard Drug Treatment Center, in particular, have helped foster a greater sense of partnership and collaboration between the IDA, County, Chamber, and many other private and not-for-profit organizations.

Two of the IDA's key goals for 2022 have not come to fruition this year: 1.) acquisition and development of an industrial park site and 2.) completion of the Lowe's water main project. Negotiations came to a standstill for a potential industrial park site earlier this year; since then, the IDA has focused its efforts on the redevelopment of the Willard Drug Treatment Center. The Lowe's water main project has been put on hold while the Village of Waterloo assesses the costs and benefits of building the remaining water loop as the funds remaining from the original PILOT increment financing (PIF) are not enough to cover the new construction estimates. Staff will continue to keep the board updated on this project as we look to 2023.

In terms of project accomplishments for the year, the IDA has approved final resolutions for 3: Bestmade Products (Loan and PILOT), Seneca Gardens Solar (PILOT), Wilkins RV (PILOT). This is somewhat of a decline compared to previous years (see the table on the next page to compare previous years' project metrics). The 3 projects that received final approval in 2022 are expected to invest \$23.9 million and create/retain 78 jobs in return for \$1.76 million in tax incentives. This equates to 7 cents in tax exemptions for every \$1 privately invested, the lowest amount of exemptions per project (\$587k) and highest return on the IDA's incentives over the past 4 years.

Looking ahead to next year, the IDA will continue to focus on relationship building and process improvement with particular attention to a few key items:

Participate on the Willard Task Force and pursue options for redevelopment of the site

- Improve the communication of IDA project information to town officials
- Develop a formal business attraction strategy
- Develop a system for prioritizing BR&E efforts
- Evaluate opportunities for development in Seneca County relative to the semiconductor industry
- Improve the process for evaluating and negotiating PILOT agreements

Staff will also look to perform 65 BR&E visits and get 5 business expansion or attraction projects to final resolution. The charts on the following page provide some insight on the IDA's project pipeline for the coming few years. Projects classified as "leads" are at the earliest conceptual stage while "prospects" have a sense of a project timeline or budget, have completed site visits, or have begun the permitting process. Of those considered prospects, staff believes 8 projects have a relatively high likelihood of converting to wins over the next 3 years. These 8 projects would bring the IDA an estimated \$8.4 million in revenue.

Seconded by Mr. Tom Murray. Motion carried. A motion was made by Mr. Tom Murray at 1:42 p.m. to come out of Executive Session. Seconded by Mr. Shipley. Motion carried

Salary Adjustment:

Mr. Brusso noted that the Governance Committee met and recommend approval of the following staff increases for 2023. A 3% increase in the salary of the Grant and Development Specialist and Office Manager and a 4% increase in the salary of the Executive Director. A motion was made by Mr. Tom Murray to approve the increases recommend by the Governance Committee. Seconded by Mr. Guthrie. Motion carried.

Adjournment:

A motion to adjourn the meeting was made by Mr. Shipley. Seconded by Mr. Tom Murray. Motion carried. The meeting adjourned at 1:42 p.m.

The next regular scheduled meeting will be held on January 5, 2023, at 12:00 Noon.
