Chairman Brusso called the meeting to order at 12:30 p.m. A quorum of the Agency's members was present.

Approval of IDA Resolution No. 2019-18 / Recapitalization of Lago Resort & Casino, LLC:

A copy of the proposed resolution was provided to board members prior to the meeting. Mr. Halpin advised board members that Lago Resort & Casino, LLC has operated del Lago Resort & Casino (the "Casino") since March 2017 and the agency entered into certain agreements, including Agency Tax Agreement, Leaseback Agreement and Benefit Recapture Agreement, dated December 15, 2015. Mr. Thomas C. Wilmot, Sr. and/or affiliates controlled by Thomas C. Wilmot, Sr. (collectively, the "Wilmot Family") currently hold 50% of the voting equity in Lago and Lago has further represented to the Agency that PGP Investors, LLC, d/b/a Peninsula Pacific, through itself and affiliates controlled by M. Brent Stevens (collectively, "Peninsula Pacific"), currently own the remaining 50% of the voting equity in Lago; however, as part of a recapitalization plan of Lago, Peninsula Pacific intends to buy all of the Wilmot Family's equity interests in Lago. In that regard, Mr. Halpin noted that the agreement documents call for the IDA board's consent for such a transfer. Mr. Aronson read the resolution as follows:
